#### How to include the Country Education Foundation in your will

Should you wish to make a bequest to the Country Education Foundation, we recommend that you:

- seek professional advice from a solicitor or trustee company; and
- discuss openly with family and dependents any intention of leaving a legacy to us.

CEF is honored to have the trust and commitment of our friends and supporters who have confirmed their intentions to leave a legacy that will help sustain the work of CEF. When you notify CEF that we have been remembered in your will, you allow us the opportunity to acknowledge and thank you in your lifetime.

Some benefactors however prefer to remain anonymous and CEF respects your wishes in this regard.

Bequest options for consideration include:

- Percentage bequest a specified percentage of the residue of your estate;
- Residual bequest the remainder of your estate once all debts, charges and other bequests have been made – this allows you to ensure that loved ones are looked after in the first instance;
- Specific bequest an asset (other than money). This may include property or shares;
- Pecuniary bequests a gift of a fixed amount of money

#### Steps in making a bequest

Decide what you would like to give to the Country Education Foundation of Australia:

- Do you have any family and/or dependents?
  If yes, we urge you to please avoid leaving an entire estate to us.
- Discuss openly with your family your bequest to us and also seek professional advice from a solicitor or a trustee.
- Advise us of your intention to make the gift in your will so that we can acknowledge and thank you in your lifetime.

#### Suggested wording

A bequest makes an especially valuable contribution to the long-term planning of the Country Education Foundation of Australia. Bequests are usually directed to CEF for use at its discretion. Such unencumbered gifts allow CEF the flexibility to use donations in areas of particular need.

In order to adhere to your wishes and avoid any unwanted disputes over your will, your intention to leave a bequest should be clearly worded and identified.

CEF welcomes enquiries to determine the most appropriate wording of your will, including ways to honor someone's memory.
